




Fig. 1. Forward current as a function of forward voltage; typical values

Fig. 2. Reverse current as a function of reverse voltage; typical values




 $f = 1 \text{ MHz}; T_{amb} = 25 \text{ }^{\circ}\text{C}$


Fig. 3. Diode capacitance as a function of reverse voltage; typical values
